*This call is addressing CIVIS young and senior researchers, administrators, representatives and members – including staff involved in community and civic/social engagement/innovation initiatives – of the 17 CIVIS universities, full and associate members of the Alliance<sup>1</sup>.*

*This call for expressions of interest is a renewed invitation to contribute to the work already done by the core team of PartiCIVIS proposal, since late 2024.<sup>2</sup>*

<sup>2</sup> In order to explore the interest and opportunities for the CIVIS Alliance to apply for such a call, a working group has been set up in September 2024 by Stefan Lang, Ass. Professor at PLUS and CIVIS Secretary General. A first call for interest launched afterwards has collected more than 100 interests, but to meet the call's requirement CIVIS needs to identify more seconded staff. Expert Group on Civic Engagement, Hub's coordinators, Institutional Coordinators and Research Unit members have been mobilized to circulate this information within the 17 institutions of CIVIS and a [info-session](#) has been organized on 30 April to present the latest [PartiCIVIS abstract](#).

## The objective in brief

To develop a staff exchange (SE) programme involving all 17 CIVIS universities and the CIVIS association to **promote research and innovation (R&I) on societal challenges through** the application of **participatory research**.

PartiCIVIS aims to **enable convergence in the practice of participatory research on societal issues with common ground in Africa and Europe by involving partners from both continents**, according to the different areas of study, with the aim of producing tangible and impactful results in both contexts.

The proposed PartiCIVIS SE project has three main objectives:

### **1) Investigate the effectiveness of participatory tools and methods reflecting key societal challenges under an African-European strategic perspective**

Adopting the CIVIS' Hubs approach, to explore and sort the existing innovation-oriented and/or transcontinental participatory research carried out by both academic and non-academic partners, coming together in specific project teams, related to the thematic priorities, such as:

1. Climate change and energy transition
2. Sustained economics, arts and cultural heritage
3. Public and planetary health
4. Urbanisation, migration and inclusive societies
5. Digital and technological change

### **2) foster evidence-based reasoning for the facilitating role of participatory research to drive social innovation**

The project provides an opportunity to compare different approaches to common societal challenges and/or to identify matching strategies and competencies in R&I activities between African and European universities in different societal contexts. The university-based civic engagement platforms participating in the project can share or jointly develop expertise, capacities, and resources.

### **3) Develop a methodological toolkit based on 'glocal' cases to enhance civic engagement and effective third mission activities of the Universities involved**

The SE programme scheme allows for the exploration of best-practice examples of civic engagement and the potential for cross-fertilisation between African and European universities. The production of a toolkit on sound participatory research methodologies, carried out in both continents by the participating universities and partners, aims to support the contribution to the 'third mission' of academic institutions by promoting a "glocally engaged university".

## Participatory research as an entry point for CIVIS universities to engage with society

**Given the common societal challenges facing Europe and Africa**, and the role of universities as transformative catalysts for our contemporary societies to drive social innovation, the common research question to shape this proposal is about: **how such**

## **engagement can be fostered through challenging teaching and research conducted with non-academic actors, following a participatory approach?**

Indeed, social innovation can be reflected in academic curriculum transformation, community-university partnerships, and helix partnerships when collaborations are established with civil society, industry and government actors. This implies concrete investments and responsibilities of the university in the design of policies aimed at having a positive impact on society through teaching, research, governance, and external leadership.

To contribute to this engagement and **to enable non-academic actors to participate in the production of scientific knowledge, participatory research can be an entry point**, as it is a research-to-action approach that emphasises direct engagement with local priorities and perspectives<sup>3</sup>.

Confirming the common goal of CIVIS university members to influence the development of societies, both locally and globally, this SE programme can:

- **foster excellence through dedicated staff mobility on participatory practices or processes** (surveys, co-construction, co-design, co-creation, action learning, PPGIS mapping, team science, etc.)
- **bring together R&I staff** (researchers, administrators) at different career stages, **who are exposed to different and non-academic host institutions** and then **return to their home institution** afterwards to **disseminate the tangible results** they have achieved in their working ecosystems.

### PartiCIVIS architecture / workpackages, training measures and secondments

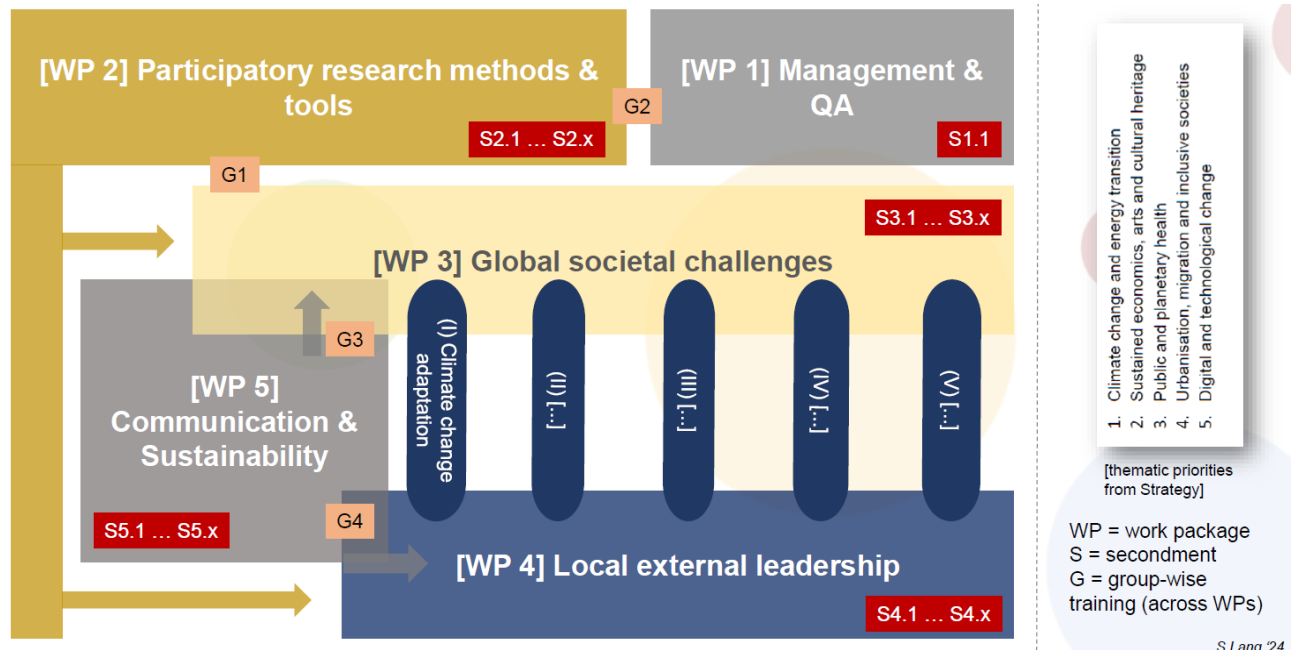
Secondments are the backbone activity to foster exchange in research. Each secondment contributes specifically to the objectives of the respective workpackage and the overall aim of the project.

In addition to the secondments, which mainly focus on forming individual excellence of the seconded researchers, network-wide training activities are carried out with a broader scope on both technical and transversal skills, addressing all active in the project.

Beyond, there are exchange and dissemination events foreseen on several scales, such as unconferences and workshops, as well as more large-scale academic conference.

## CIVIS target group

The proposal provides an opportunity to articulate a staff mobility exchange for two main categories of the university staff:

- **Administrators** involved in the civic engagement platforms (open labs, expert groups, ...)
- **Researchers** (doctoral, post-doctoral and senior) who carry out participatory research projects, either as a subject or as a methodology.

The diversity of profiles that will be involved in the PartiCIVIS proposal aims to contribute and enrich the research culture through a dynamic ecosystem that allows for career diversification and development, interoperability with all sectors of society, in line with the European Commission's European Charter for Researchers initiative<sup>4</sup>.

## Contribution to research and innovation objectives

The common objectives for both African and European countries are to improve R&I ecosystems going beyond existing cooperation to create or strengthen long-term collaborations, expand working networks, share knowledge and transform cutting-edge research into innovative products and services.

Since the adoption of the AU-EU Innovation Agenda in 2023<sup>5</sup>, **joint research & innovation (R&I) has become a key priority in and for the development of the Africa- Europe partnership**, as an indispensable means to address common global societal challenges. Indeed, within the framework of the AU-EU agenda, the strengthening of scientific and academic mobility opportunities to support the co-design and co-reinforcement of training programmes through research and innovation projects is in line with the socio-economic needs of the countries/regions concerned and is recognised as one of the short-term actions to strengthen 'capacities for science'<sup>6</sup>.

Universities have a crucial role to play in this agenda, as they are hubs for innovation-oriented research as well as for the training of future researchers and innovators, and are already much more than that on both sides of the Mediterranean. **In line with their commitment to the "third mission" of academia** - societal engagement - many of them not only **maintain local innovation centres** to support start-ups and industrial cooperation. They have also **established platforms for collaboration with non-academic stakeholders on innovative solutions to societal challenges at the local level**.

Following the vision of our CIVIS University Alliance, to established civic engagement as a fundamental value and a practical goal in **Open Labs** and **thematic Hubs**, the PartiCIVIS proposal entails a broad and comprehensive thematic scope on the AU-EU agenda's priority areas such as public health, green transition, digital technologies; thereby ultimately strengthening each HEI's capacities for science.

### Relevance to the MSCA SE criteria

The transfer/sharing of knowledge and skills offered by the MSCA SE programme touches on three dimensions for the success of the project:

#### International

The CIVIS Alliance, by its very nature, offers an international dimension benefiting from its extended geography in Europe and in Africa and ensuring the mobility across the two continents.

The PartiCIVIS proposal is based on the assumption that the **cooperation between researchers and innovators from different local (regional) contexts**, working on the same or similar challenges, **can significantly help them to overcome the limitations of merely local representations of societal challenges or unilaterally global solutions**. Cross-continental collaborations with a 'glocal' perspective can thus increase the relevance of R&I results. This can take on the form of truly joint R&I projects between African and European participants, but also the sharing of expertise or mutual access to R&I capacities.

#### Intersectoral

The more **recent notion of social innovation, which involves non-profit actors in the implementation of R&I policies and practices** goes beyond a more traditional framework in which innovation is understood exclusively as a driver for a business-oriented approach, and

new research results and technologies are commercialised and transformed into marketable products to be integrated. The SE programme can offer a process of developing and implementing practices and social relations to address societal needs, thus remaining open to business-oriented actors and processes in this context.

The PartiCIVIS proposal offers the opportunity to think ahead a twofold commitment to ensure the active involvement of universities in social innovation: first, to invest in in-depth reflection on how to involve different stakeholders while maintaining high research standards, and second, to point to the necessary institutional and research policy changes that universities are undertaking.

### **Interdisciplinary**

The focus of the proposed SE programme on civic and societal challenges leads to the adoption of a transdisciplinary approach to R&I. It is based on the widely recognised recognition that no single academic discipline and its associated methodologies are alone capable of providing a holistic view of societal challenges and therefore of devising effective and sustainable approaches to addressing them.

While this already requires a multi- or interdisciplinary approach, **CIVIS transdisciplinarity approach goes a step further by opening up the very definition of 'societal challenge' and related research questions to input from non-academic stakeholder communities.**

### Concrete implementation of the SE programme

Ideally, PartiCIVIS will involve all 11 European and 6 African universities that are members of the CIVIS Alliance<sup>7</sup> as well as the newly established CIVIS Association and different dimensions of collaborations are possible:

- **Using existing joint, challenge-oriented, transdisciplinary education and participatory research initiatives** developed within the 5 five thematic Hubs as well as civic engagement platforms/CIVIS Open Labs. **There is no need to create new formats for R&I.**
- **Building on** the previous dedicated R&I programme under Horizon Europe – RIS4CIVIS, and potential **synergies with CIVIS Alliance projects** and programmes such as PolyCIVIS, Blended Intensive Programmes (BIPs), Seed Funding projects.

An MSCA SE programme would allow the **exchange of staff for 1 up to 12 months<sup>8</sup>** (based on secondments) **for joint training and networking activities.**

Taking into account the R&I objectives outlined above and other objectives of the partners' network, PartiCIVIS could thus include the following, concrete activities (further items or changes are possible!)<sup>9</sup>:

<sup>9</sup> In line with the MSCA SE eligibility criteria, allowing for single-sector exchanges if partners from non-associated third countries are involved, as well as the focus on the role of universities in R&I, the programme will not target at the inclusion of non-academic participants in the staff exchange itself. However, they can and should be integrated in networking and training events like conferences and in local activities.

- **Research stays of early career researchers** (mainly PhDs, Post docs) at a partner institution to carry out participatory research projects with an emphasis on research in collaboration with community/social/open labs and/or involving civic engagement.
- **Research stays of senior scientists or academic staff** with the same profile at a partner institution for joint participatory research project.
- **Developing future-oriented career paths** towards civic engagement and social innovation.
- **Stays of research, managerial, technical staff, involved in our civic engagement projects and (platforms)**, at a partner university for training purposes and/or developing joint participatory research projects.
- **Joint workshops/conferences** of research, managerial, technical staff involved on R&I, civic engagement and participatory research as tool for social innovation.
- **Training activities** of involved staff in civic engagement and participatory research (platforms).

### Expected impact of the programme

#### For participating staff members (individual level):

- Enhanced research, training, and networking opportunities through stays at partner universities and participation in related events
- Enhanced career perspectives in the R&I realm and also outside academia

#### For participating universities (institutional level):

- Contribution to their commitment to social innovation through the development of new R&I collaborations, skill development of staff, knowledge transfer, and increased international visibility of their civic engagement platforms and projects
- Enhanced opportunities for postgraduate research training

#### For the envisaged consortium (alliance level):

- Strengthened research profile of the alliance in direct relation to its main goals - social challenge orientation, civic engagement, African-European partnerships
- Opportunity to explore and eventually develop the collaboration between CIVIS members and partners in the realm of civic engagement/Open Labs

#### For R&I in Europe and Africa (ecosystem level):

- Direct contribution to the R&I objectives of the AU-EU Innovation Agenda and explorative application of the partnership formats outlined therein, i.e., European University alliances and MSCA
- Insights on the significance of university's civic engagement for R&I, relevant for R&I policy and practice
- Development of new teaching and research formats and contents for educating civically minded, challenge-oriented, transdisciplinary trained innovators
- Tangible changes within the communities themselves involved in the participatory research initiatives developed through the CIVIS Hubs' thematic priorities approach.



## Budget scenario

## What is funded?

- Mobility of seconded staff (top-up allowance for travel, accommodation, subsistence costs), on top of the salary paid by the home organisation; special needs allowance, if applicable
- research, training and networking activities (conferences and publications)
- management and indirect costs

## Point of attentions:

- It is not possible to have the same staff member funded at the same time under two or more MSCA grants for the same activity. Furthermore, seconded staff need to be committed full-time to the MSCA project
- Any secondments planned to do exclusively management activities (e.g., project coordination meetings, report drafting, etc.) as well as communication, dissemination and training not related to the R&I activities, will not be eligible.

<sup>10</sup> UNIL is not directly eligible for funding; its possible role needs to be clarified.
